SHELTER AND SERVICES

SHELTER OPERATIONS

In December 2020 of CRA's operations, the Keys Overnight Temporary Shelter had a total number of 229 unduplicated clients with an average stay of 124 clients per night, and an average stay of 17 nights per client. The Shelter is a 24hour facility. Under the direction of Shelter Manager, Lottie Bowechop, the database shows that Shelter staff did 68 New Enrollments/Intakes. There were 3,853 bed nights during the month of December.

Additionally, SHAL's hardworking Shelter staff served, roughly, 100 breakfasts, 50 lunches and 120 dinners per night. Providing, roughly, 7,595 meals during December 2020. Since the shelter is 24 hours, Breakfast, Lunch, and Dinner, is served to CRA Shelter residents. Dinner is provided by the volunteers at **S**t. Martha's Ministry (formerly St. Mary's Soup Kitchen). Breakfast is provided by CRA and lunch is provided by Star of the Sea Foundation (SOS) through a partnership which will continue into 2021. Thank you all for your help!

COVID AND KOTS

The evolution of the Keys Overnight Temporary Shelter over the Covid-19 pandemic has not been an easy feat. The Shelter went to a 24-hour facility almost overnight. KOTS staff had to expand the footprint to accommodate the necessary social distancing for the roughly 120 people that stays per night. Each night, Shelter Staff utilize two large tents that have had to be taken down and put back up depending on threatening weather. CRA is grateful to the City of Key West and especially their Community Services Department for all of their ongoing help through these transitions.

CASE MANAGEMENT AND SERVICES

CRA's Case Management Team

CRA'S CASE MANAGEMENT

CRA's Case Management team, Teresa Wallace and Anne Barnett, provided 215 services to 118 Unduplicated clients in the month of December operations. CRA Case Managers provide services to both sheltered and unsheltered clients, with an average of 2 service per client during December. CRA Case Managers did 36 new client enrollments/intakes. Additionally, CRA's Case Managers helped 4 clients with obtaining their birth and/or marriage certificate and they assisted 23 clients with getting a Florida ID. These type of ID services help in client's establishement of supportive services, jobs and housing. CRA's Case Managers were also able to provide 2 new client's with a 7-day bus pass for the purposes of making it easier to look for jobs and/or making it easier to get around due to a disability (acute or chronic).

Case Managers provided 30 clients assistance in obtaining shoes/clothing that were necessary for their new jobs or job searches. 29 of these clients were given clothing vouchers for them to use at the Salvation Army. This voucher allows clients to pick out a few clothing items, a backpack, and shoes (if they have them). CRA was able to help purchase work clothing for 1 client that had promise of employment and had no other means of obtaining these items.

Rental & Utility Assistance

Through a very generous grant from the Continuum of Care (COC), CRA's Case Managers, Teresa Wallace and Anne Barnett, were able to launch their first Housing Rental Assistance and Utility Assistance Program. The program will help reduce the amount of Homelessness. Rental assistance sharply reduces adults in homeless families, studies find, likely in part by easing the stress related to the risk of evictions, homelessness, and other housing instability. In addition, it connects these adults to other wrap around services to aid in the help to keep these persons housed. So far two clients/families have been assisted with rental assistance. Relocation Assistance Program

Thanks to grant funding from the Monroe County Continuum of Care (COC), 1 client was successfully relocated, during December to a better situation, where they have housing, support and/or employment waiting for them. CRA Case Managers, collaborate with client's friends and family to ensure the best possible scenario for the client. This collaboration sometimes ends up in a relocation. The Florida Keys are not always the best place for people struggling with homelessness to overcome their own personal battles. Whether it be health issues or overcoming the high cost of living in the Florida Keys, our relocation program helps to overcome these hurdles. By providing a one-way bus ticket via Greyhound, clients can relocate to a better living situation.

Jump Start Bike Program

The bike program continues to be a great success, with many donations of bikes coming in over the past couple of months. During December, the program was able to provide 8 bikes to clients.
